RECOMMENDED ACTION:

That the Town Council adopt Resolution No. 2012-23 opposing section 7.8 of the State Water Resources Control Board (SWRCB) Final Draft Water Quality Control Policy for Siting, Design, Operation, and Maintenance of Onsite Wastewater Treatment Systems (OWTS Policy), dated March 20, 2012.

SUMMARY:

On March 20, 2012 the SWRCB released a final draft of the OWTS Policy. The stated purpose of the policy is to allow the continued use of OWTS while protecting water quality and public health. The policy establishes a statewide, risk-based, tiered approach to the regulation and management of OWTS. OWTS are placed into tiers, with different levels of requirements depending on which tier they fall under.

Nearly seventy-five percent (75%) of the population within the Town of Apple Valley boundaries reside in dwelling units that are served by septic tanks. Currently, septic tanks are allowed at a density of one dwelling unit or its equilvalent per 0.5 acres of land. Section 7.8, page 24, of the OWTS Policy would restrict new or replacement septic systems under Tier 1 to a maximum density of one dwelling unit or its equilvalent per 2.5 acres of land.

On April 9, 2012 Town staff met with local city officials from surrounding agencies along with Victor Valley Wastewater Reclamation Authority (VVWRA) to discuss this final draft policy. All of the attendees at the meeting were asked to come up with comments to

this proposed policy and forward them to the Town. These comments would be discussed again at a follow up meeting on April 19, 2012.

On April 19, 2012 Town staff met again with local city officials and VVWRA to discuss the comments that were submitted. Also in attendance at this meeting were two representatives from the local regional water board, Lahontan. Lahontan suggested that we send our comments to the SWRCB by the May 4, 2012 deadline. Town staff submitted the Town's written comments to the SWRCB and to the Town's lobbyist. The other surrounding agencies were asked to submit their comments directly to the SWRCB as well.

BACKGROUND:

In the past property owners have been able to enjoy the potential to utilize their land with up to one dwelling per 0.5 acres for dwellings on septic systems; therefore this change in the density requirement has the potential to negatively impact many property owners within the Town. The policy appears to allow new development at higher densities than what is allowed under Tier 1, but only if the local agency implementing the policy prepare a Local Agency Management Program (LAMP). The preparation of a LAMP may not be a reasonable alternative because it would be costly, difficult to implement, and would still require approval from the SWRCB.

In 1993 the Unites States Geological Survey (USGS) issued Water Resources Investigation Report 93-4137 indicating that in the Mojave River Basin "current onsite domestic-wastewater disposal practices pose little immediate threat to the local ground-water resource." The USGS report further indicates septic systems contribute substantial return flows to groundwater and slow the decline of groundwater levels. This is a significant benefit to the Town's water resources.

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF APPLE VALLEY, CALIFORNIA, OPPOSING SECTION 7.8 OF THE STATE WATER RESOURCES CONTROL BOARD'S FINAL DRAFT SEPTIC TANK POLICY

WHEREAS, on March 20, 2012 the State Water Resources Control Board (SWRCB) released the Final Draft Water Quality Control Policy for Siting, Design, Operation, and Maintenance of Onsite Wastewater Treatment Systems ("Policy"); and

WHEREAS, approximately seventy-five percent (75%) of the population within the Town of Apple Valley boundaries (Town) reside in dwelling units that are served by onsite wastewater treatment systems (OWTS), also known as septic systems; and

WHEREAS, under current regulations property owners within the Town have enjoyed the ability, or potential ability, to develop land at a density of up to one dwelling unit for 0.5 acres, for properties relying on septic systems; and

WHEREAS, under Tier 1 of the policy the maximum density allowed for properties relying on septic systems would be restricted to one dwelling unit per 2.5 acres (Section 7.8 of the Policy). This portion of the policy, among others, has the potential to negatively impact property owners within the Town and the economic development of the Town at a crucial time in its economic history; and

WHEREAS, in 1993 a report was issued by the United States Geological Survey (USGS Water-Resources Investigation Report 93-4137) indicating that in the Mojave River Basin "current onsite domestic-wastewater disposal practices pose little immediate threat to the local ground-water resource"; and

WHEREAS, the USGS report further indicates septic systems contribute substantial return flows to groundwater and slow the decline of groundwater levels. This is a significant benefit to the Town's water resources.

NOW, THEREFORE, BE IT RESOLVED that the Town Council of the Town of Apple Valley herby:

 Opposes Section 7.8, and related provisions, of the Final Draft Water Quality Control Policy for Siting, Design, Operation, and Maintenance of Onsite Wastewater Treatment Systems

Unless otherwise noted, the effective date of this Resolution shall be May 8, 2012.

BACKGROUND

In May 2011 the State Water Board held public scoping meetings on the SED to seek input on the range of project actions, alternatives, reasonably foreseeable methods of compliance, significant impacts to be analyzed, cumulative impacts, if any, and mitigation measures that will reduce impacts to a less than significant level; and to eliminate from detailed study issues found not to be important. On September 30, 2011 staff released a public draft of the OWTS Policy and SED for review and comment. In addition, staff held 8 public workshops at 4 locations around the state to hear comments and answer questions from public agencies and interested persons. Staff has revised the OWTS Policy and SED in response to public comment.
