Subject: AWARD CONTRACT FOR THE CENTRAL ROAD OVERLAY PROJECT

RECOMMENDED ACTION:

Award a contract to Sully-Miller Contracting Co. in the amount of \$237,000.00 for the Central Road Overlay Project 2012-08 – Bear Valley Road to Poppy Road, subject to "Approval as to Form" by the Town Attorney and "Approval as to Content" by the Town Manager.

SUMMARY:

On August 8, 2012, the Town received and opened bids for the subject contract. This project includes providing necessary labor, equipment and materials for the overlay of Central Road from Bear Valley Road to Poppy Road.

The bid results are as follows:

GM Sager Construction, Inc.	\$262,290.90
Cooley Construction, Inc.	\$273,169.60
Matich Corporation	\$282,000.00

Staff is satisfied that Sully-Miller Contracting Co. is a responsible contractor for this work.

BACKGROUND:

The Central Road Overlay Project will consist of the repaving of 2 miles of Central Road from Bear Valley Road to Poppy Road. The paving application will be a 1.25-inch overlay of SC3000 asphalt over the entire section of road. The Town has jurisdiction over the full-width of Central Road between Bear Valley Road and Las Tunas Road (0.5-miles), and the Town and County jurisdictions share equal half-widths from Las Tunas Road to Poppy Road (1.5-miles). The jurisdictional split of this project is a 60/40 split, so the Town will be responsible for 60% (\$142,200) of the total cost and the County will pay 40% (\$94,800) of the total cost.

DISCUSSION:

The bid documents for the project were reviewed by staff for accuracy and constructability, and were presented to Town Council for approval on June 26, 2012. The bid documents and the authorization to advertise were approved by Town Council and the bid opening was held on August 8, 2012.

This portion of Central Road being improved is located in the southern area of Town and is one of two main arterials used to get from Highway 18 into the County and on into Hesperia.

FISCAL IMPACT:

Funding for this projecthas been appropriated in the Town Council approved 2012-2013 Capital Improvement Projects Budget. The Townwill be responsible for 60% (\$142,200) of the total cost and the County will be responsible for 40% (\$94,800) of the total cost.


