SUMMARY:

Last April, the Town Council and staff participated in a workshop with Flint Strategies to review our progress on Vision 2020 and revisit the goals of the document in light of the current economic climate.

Based on the results of the workshop, Flint Strategies compiled an updated list of priorities and core values. Tonight, Kendall Flint will present to you a proposed revision of the Town's Vision 2020 priorities.

CORE VALUES

The Town's organizational culture is built on the following Core Values:

- Zoning Integrity
- Customer Service
- Public Safety
- Partnerships

GOALS

In light of current economic conditions, the Town Council has reduced the overall number of Goals from 10 to 8 to better reflect its priorities. Goals appear below in order of priority.

- 1. Public Safety: A safe community.
- 2. Public Infrastructure: Adequate and well-maintained infrastructure.
- 3. Economic Development: A thriving economy.
- 4. Transportation: A strong transportation system.
- 5. Parks and Recreation: Ample parkland and diverse recreational opportunities.
- 6. Quality Staff: Highest quality staff.
- 7. Promote Partnerships: Develop meaningful public / private partnerships.
- 8. Revenue Generation: Exploration of options for departments to provide revenue-generating services.

STRATEGIES AND TACTICS

GOAL #1: PUBLIC SAFETY²

Objective: Maintain and enhance the high level of public safety in Apple Valley.

Strategies

- 1.1 Maintain funding for public safety.
- Ensure police staff levels keep pace with population growth. 1.2
- 1.3 Focus on maintaining a safe environment for retail businesses.
- 1.4 Focus on gang control and prevention.
- 1.5 Proactively address blight-related public safety issues.
- 1.6 Maintain programs for youth in Apple Valley.³
- 1.7 Engage the community in maintaining public safety.

GOAL #2: ADEQUATE AND WELL-MAINTAINED INFRASTRUCTURE

Objective: Provide the infrastructure necessary for Apple Valley's residents and businesses to live and grow.

Strategies

- 2.1 Continue to work cooperatively with neighboring jurisdictions and agencies to develop the sub-regional wastewater treatment facility.
- 2.2 Seek to resolve infrastructure⁴ issues in North Apple Valley.
- 2.3 Complete and implement the Watershed Management Plan.
- 2.4 Promote greater public understanding of water resources and other public infrastructure issues through education and outreach.

GOAL #3 A THRIVING ECONOMY

Objective: Enhance and expand the Town's economic base.

Vision 2020 - Revised

- 3.1 Focus on job creation and development of a trained workforce.⁶
- 3.2 Develop a comprehensive Business Attraction and Retention Program.
- 3.3 Market the Town of Apple Valley to businesses and entrepreneurs.

GOAL #4 TRANSPORTATION

Objective: Develop and maintain a comprehensive transportation system.

- 4.1 Complete key transportation projects including the Yucca Loma Bridge, Falchion Interchange and the High Desert Corridor (E-220)
- 4.2 Achieve a satisfactory level of traffic flow and pavement condition on all Town roadways.
- 4.3 Maintain a network of multi-use trails and bicycle paths.⁷
- 4.4 Support the expansion and enhancement of bus transit service throughout Apple Valley.
- 4.5 Coordinate with neighboring jurisdictions and regional agencies to seek state and federal funding for transportation projects.
- 4.5 Promote greater understanding of transportation system needs and benefits to Town residents.
- GOAL #5 AMPLE PARKLAND AND DIVERSE RECREATIONAL OPPORTUNITIES⁸

Objectives: Maintain the Town's network of parkland and recreational opportunities.

- 5.1 Maintain youth, senior and equestrian recreation programs.⁹
- 5.2 Identify and secure funding sources for parks and recreation facilities and programs.
- 5.3 Partner with other public and private organizations to provide park and recreation facilities and programs.
- 5.4 Develop Apple Valley County Club as a self-sustaining facility.

Vision 2020 – Revised

Objective: Retain the highest quality Town staff.¹⁰

- 6.1 Provide a positive work environment.¹¹
- 6.2 Provide education and training opportunities to maximize staff utilization, retention and plan for staff succession.¹²
- 6.3 Focus on customer service.
- 6.4 Regularly audit Council-staff communications and internal staff communications
- 6.5 Promote local volunteerism and civic engagement.
- 6.6 Focus on work-life balance to retain staff.

GOAL #7 PROMOTE PARTNERSHIPS

Objective: Develop meaningful partnerships in both the public and private sectors, increasing opportunities for funding projects and supporting economic development.

Objective: Identify potential revenue streams in both public and private sectors.

- 8.1 Encourage all departments to explore and implement viable revenue generating opportunities in both public and private sectors.
- 8.2 Adopt a private sector business model for providing services.
- 8.3 Explore opportunities for renewable energy in Apple Valley.¹³
