## **RECOMMENDED ACTION:**

That the Town Council establish October 9, 2012 at 6:30 p.m., as the date and time certain for the purpose of conducting the first of two (2) Community Development Block Grant (CDBG) and HOME Investment Partnerships Programs (HOME) public hearings necessary to develop the Town's Consolidated Plan/ Second Year Action Plan for FY 2013-2014.

## SUMMARY:

The Code of Federal Regulations regarding the Consolidated Plan requires a minimum of two (2) public hearings prior to submitting the Town's Consolidated Plan to the U.S. Department of Housing and Urban Development (HUD). The first of these public hearings should be conducted for the purpose of soliciting public input in the development of the Second-Year Action Plan. The Second Year Action Plan is a major component of the Consolidated Plan and will determine the specific use of CDBG and HOME funds for the 2013-2014 program year. A second public hearing will be conducted on April 23, 2013 for the purpose of receiving the Community Development Citizen Advisory Committee (CDCAC) funding recommendations and public input regarding such recommendations.

It has been the practice of the Town Council to establish funding priorities for the next program year shortly after receiving public input at the first public hearing. Funding priorities will be set at the October 23, 2012 Town Council meeting. The list of funding priorities is then provided to applicants during the Technical Workshop on November 7, 2012; a free workshop that is held to assist CDBG applicants with any questions regarding the development of their applications/proposals.

A copy of the tentative 2013-2014 Consolidated Plan Schedule is attached for your information.
