Subject: FEE WAIVER REQUEST FOR THE HANSON CYCLING FOUNDATION OCTOBER 8, 2012 AT THE TOWN HALL RECREATION CENTER AND OCTOBER 20, 2012 AT CIVIC CENTER PARK.

RECOMMENDED ACTION:

For good cause shown, and finding a waiver will serve a public purpose, approve the waiver of the Facility Rental Fee of \$1,041.20.

SUMMARY:

The Hanson Cycling Foundation is requesting use of Civic Center Park on October 20, 2012 in order to host the 5th Annual Tour de Apple Valley. The Tour de Apple Valley event promotes cycling in Apple Valley for residents and visitors alike. Previous events have brought in cyclists of all ages and skill levels throughout Southern California. The proceeds from this event will be donated to the Apple Valley Police Activities League to allow them to continue to run programs for underserved youth in the community.

The fees come to \$1,041.20 and include use of the Town Hall Recreation Center on October 8th, use of Civic Center Park on October 20th and the Special Event Permit fee. The organization will still be required to provide a Certificate of Insurance.

BACKGROUND:

On 8-14-01, the Town Council adopted a policy stating fees can be administratively waived for a local public agency, a utility company or service district, or a similar entity providing an essential service to the general community, whereas, non-profit requests for fee waivers must go before the Town Council for consideration.
