# **BUSINESS OF THE COUNCIL**

14. Amendment No. 3 to the Happy Trails Villas Owner Participation Agreement for the Construction of 34 Single-Family Attached Units at the Northwest Corner of Kiowa and Highway 18.

Lori Lamson, Director of Community Development, presented the staff report as filed with the Town Clerk.

Council Member Stanton asked a series of questions regarding the number of units that are currently in escrow and ready to close. She also questioned how many units, moderate and low income, are going to be unrestricted with respect to income level for sale.

Council Member Nassif questioned whether or not this project would impact the Town's regional housing numbers.

Ms. Lamson stated that this project would improve our numbers and meets all state requirements

Adolph Collazo, Real Estate Broker, commented on the time he has dedicated to assist interested buyers to become homeowners. He believed that the Town is at its limits regarding moderate buyers. He felt that the community would benefit by the Town moving forward.

Tom Piper, Apple Valley, requested to know if the down payment assistance program is for local residents only.

Councilmember Stanton responded that the down payment assistance program is offered to anyone who qualifies.

Mr. E.T. Snell, Apple Valley, questioned whether or not the units would become Section 8 units. He discouraged the Town Council from allowing the complex to become a Section 8 complex.

Council Member Nassif reminded the public that these units are Single-Family owner occupied units.

Bernadette McNulty, Apple Valley, expressed concern regarding a lack of handicap accessibility for these units.

Council Member Stanton asked questions regarding ADA Requirements for this project.

John Brown, Town Attorney, provided additional clarification to the Town Council and the public regarding ADA Requirements for single family units.
