RECOMMENDED ACTION:

Authorize the dedication of a Town owned strip of land (750 square feet) along Highway 18 for Public Right-of-Way.

SUMMARY:

Staff requests that Town Council authorize the dedication of a Town owned strip of land, 75 feet long and 10 feet wide, along Highway 18 for Public Right-of-Way purposes. This dedication will place the Public Right-of-Way in front of the Town owned property (old maintenace yard) in alignment with the adjacent properties.

BACKGROUND:

During construction of the Highway 18 landscaped median it became apparent that a portion of land that was shown on the project's plans as Public Right-of-Way had never been dedicated. This property is the old maintenance yard and is owned by the Town. In this section of Highway 18, the Right-of Way half-width is 110 feet while in front of the old maintenance yard it is only 100 feet.

DISCUSSION:

The Right-of-Way dedication documents have been reviewed and staff is satisfied with the accuracy of said documents.

FISCAL IMPACT:

No fiscal impact.
