## REGULAR MEETING MINUTES – February 12, 2013

#### **CALL TO ORDER:**

Marc Puckett, Assistant Town Manager, Finance and Administration, explained the expenditures listed within the report and explained that the Town receives no revenue from the Pro Shop since the Town contracts out that service.

Dennis Cron, Assistant Town Manager, Municipal Operations/Contract Services, commented on the changes to the course in an effort to improve operations and reduce costs.

Michael Drake, Victor Valley Christian School, stated that the school has not yet played nor paid a fee at the Apple Valley Golf Course.

Mr. Cron explained that the fees offered for the school are comparable to rates offered by other cities.
