## **Staff Report**

APPLICANT: Town of Apple Valley

**PROPOSAL:** To consider a General Plan Conformity Finding for the Town's Capital Improvement Program for fiscal year 2013-2014.

ENVIRONMENTAL DETERMINATION:

ATION: The General Plan conformity finding is not a project as defined by CEQA. Also, since this is a General Plan consistency finding, the adopted General Plan EIR would be considered adequate CEQA documentation.

LOCATION: Town wide

- **RECOMMENDATION:** Adopt Planning Commission Resolution No. 2013-02 which finds the proposed Capital Improvement Program for Fiscal Year 2013-2014 consistent with the goals and policies of the Town's General Plan.
- A. <u>Project Summary:</u> The Planning Commission is being requested to review the attached Capital Improvement Program (CIP) for FY 2013-2014 to determine consistency with the General Plan. This is the first year of what will be an annual report for General Plan consistency for the program. The CIP is proposed to be adopted by the Town Council with the FY 2013-2014 budget.

## <u>ANALYSIS</u>

The CIP is a document addressing the long term capital improvement needs of the Town. The CIP also provides a relatively long term (7-year) strategy that will be approved annually in concept by the Council. The attached CIP for FY 2013-2014 is one year of the CIP 7-year Plan. Section 65401 of the California Government Code requires the Planning Commission to annually review the CIP of the Town for consistency with the General Plan.

The attached CIP for FY 2013-2014 has been included for the Commission's reference. Staff has reviewed these projects and recommends adoption of the attached Resolution No. 2013-02 finding the draft CIP consistent with the General Plan. Staff has listed the applicable General Plan Goals, Policies and Programs with each project.

**Transportation** – The draft CIP contains a list of street and bike path improvements including, Apple Valley Road @ Bear Valley Rd SE Corner Improvements, Apple Valley Road @ Town Center Dr Improvements, Civic Center Parking Lot Circulation Improvements, Hwy 18 West End Widening, Nakash Road Resurfacing, Navajo Road Rehabilitation, Paving Priorities, Signal - Bear Valley Rd at Mohawk Rd, Yucca Loma Bridge, Yucca Loma Road Widening, Rancherias Road Resurfacing, SANBAG Congestion Management Plan, Rancho Verde Elementary School Safe Route to School, and review and upgrade of the existing bike lane network installations.

These projects are consistent with the following General Plan goals and policies:

## **Circulation Element – Community Development**

## Goal

The Town shall continue to maintain and expand a safe and efficient circulation and transportation system.

## Policy 1.B

The Town shall establish and maintain a 5-Year Capital Improvement Program for streets.

## Program 1.B.1

The Town Engineer and Department of Public Services shall maintain a Capital Improvement Program for 5 years, and update it annually.

## Program 1.C.1

An inventory of discontinuous sidewalks on all qualifying roadways shall be compiled by the Town Engineer and Department of Public Services, and individual improvement projects shall be funded through the Capital Improvement Program to connect these sidewalks.

## Program 1.C.3

Safe routes to school shall be developed in conjunction with the School District.

## Policy 1.J

The Town shall implement a coordinated and connected bicycle lane network consistent with the Bicycle Lane Map in this Element.

## Program 1.J.2

The Town shall inventory bicycle lane deficiencies within the existing roadway system, and include improvements to make these improvements consistent with this Element in the Capital Improvement Program

**Stormwater -** The draft CIP contains an item related to stormwater, including miscellaneous Storm Damage Repairs, Upgrades & Dry Wells.

These projects are consistent with the following General Plan goals and policies:

## Flooding and Hydrology Element – Environmental Hazards

#### Goal

Protect lives and property from flooding hazards through a comprehensive system of flood control facilities throughout the Town.

## Policy 1.A

Upgrade the Town's local and regional drainage system through proactive planning and coordination with other responsible agencies.

## Program 1.B.2

Continue active participation in regional flood control and drainage improvement efforts.

**Wastewater-** The draft CIP contains a list of wastewater related projects including, Lift Station AD#3A-1 Improvements, Lift Station AD#2B Improvements and Jess Ranch Lift Station Project.

These projects are consistent with the following General Plan goals and policies:

## Public Buildings & Facilities Element – Public Services & Facilities Policy 1.C

The Town shall ensure that every effort is made to facilitate cost-effective and timely extension and expansion of community-development support services.

## Program 1.C.1

In conjunction with local utility and service providers, the Town shall coordinate its Capital Improvement Program to ensure that adequate and cost-effective services and facilities and capacities are provided to serve future growth and development.

<u>Environmental Assessment:</u> The General Plan conformity finding is not a project as defined by CEQA. Also, since this is a General Plan consistency finding, the adopted General Plan EIR would be considered adequate CEQA documentation.

#### RECOMMENDATION

That the Planning Commission adopt Planning Commission Resolution No. 2013-02 which finds the proposed Capital Improvement Program for fiscal year 2013-2014 consistent with the goals and policies of the Town's General Plan.
