## **RECOMMENDED ACTION:**

That the Town Council receive, ratify, and file the Commercial Warrants Schedule as presented.

### SUMMARY:

Commercial warrants were issued from May 1 through May 31, 2013 in the amount of \$4,866,625.61 net of voids covering issued warrant #'s 100093 - 100701.
