RECOMMENDED ACTION:

For good cause shown, and finding a waiver will serve a public purpose, approve the waiver of the Facility Rental Fee of \$165.25.

SUMMARY:

The Hanson Cycling Foundation is requesting use of Civic Center Park on October 19, 2013 in order to host the 6th Annual Tour De Apple Valley. The Tour De Apple Valley event promotes cycling in Apple Valley for residents and visitors alike. Previous events have brought in cyclists of all ages and skill levels throughout Southern California.

The total fee waiver requested is \$165.25 and includes the use of the Recreation Center for an organizational meeting(Date and necessity TBD) and use of Civic Center Park on October 19, 2013. The organization will still be required to provide a certificate of insurance, security and other event amenities required to ensure a safe and productive event.

BACKGROUND:

On 8-14-01, the Town Council adopted a policy stating fees can be administratively waived for a local public agency, a utility company or service district, or a similar entity providing an essential service to the general community, whereas, non-profit requests for fee waivers must go before the Town Council for consideration.
