RECOMMENDED ACTION:

That the Town Council establish October 22, 2013 at 6:30 p.m., as the date and time certain for the purpose of conducting the first of two (2) Community Development Block Grant (CDBG) and HOME Investment Partnerships Programs (HOME) public hearings necessary to develop the Town's Consolidated Plan/ Third Year Action Plan for FY 2014-2015.

SUMMARY:

The Code of Federal Regulations regarding the Consolidated Plan requires a minimum of two (2) public hearings prior to submitting the Town's Consolidated Plan to the U.S. Department of Housing and Urban Development (HUD). The first of these public hearings should be conducted for the purpose of soliciting public input in the development of the Third-Year Action Plan. The Action Plan is the annual planning component of the Consolidated Plan and will determine the specific use of CDBG and HOME funds for the 2014-2015 program year. A second public hearing will be conducted on April 22, 2014 for the purpose of receiving the Community Development Citizen Advisory Committee (CDCAC) funding recommendations and public input regarding such recommendations.

It has been the practice of the Town Council to establish funding priorities for the next program year shortly after receiving public input at the first public hearing. Funding priorities will be set at the November 12, 2013 Town Council meeting. The established funding priorities provide guidance for the preparation and approval of CDBG proposals. The CDBG Technical Workshop to be held on November 14, 2013 will provide a forum to assist applicants in the development of their applications/proposals.
