Subject: APPROPRIATION OF ASSET SEIZURE FUNDS

RECOMMENDED ACTION:

That the Town Council approve the attached Budget Amendment No. 14-06 appropriating available Asset Seizure Fund resources for the purchase of office equipment and other expenditures as discussed herein.

SUMMARY:

Asset Seizure Funds are received by the Town periodically due to drug enforcement activities. Asset forfeitures/ seizure funds are tracked and reported to the Federal Government based upon case activity. Upon the conclusion of each case, assets forfeited or seized are re-distributed to local agencies based upon the assets forfeited or seized within each jurisdiction. These funds are then used for the enhancement of future drug enforcement activities. Since adoption of the Fiscal Year 13-14 Budget, the Town has received \$28,732 in asset seizure funds. Together with the existing \$18,576 in available fund balance in the Asset Seizure Fund, a total of \$46,000 is available for appropriation. At the time of adoption of the FY 13-14 Budget, no funds were requested to be appropriated. Adoption of the attached Budget Amendment No. 14-06 will appropriate available resources for the enhancement of drug enforcement activities.

BACKGROUND:

Approval of the attached BA No. 14-06 will appropriate \$14,760.00 from the Asset Seizure fund balance to purchase updated and more efficient work space, file and supply storage for staff assigned to the Apple Valley Police Department. These staff members have various responsibilities including those related to drug enforcement activities. This purchase will allow for more efficient utilization of the existing work space. Of the the remaining \$31,240.00 of Assest Seizure funding, \$6,200.00 will remain available for additional office equipment and upgrades, \$15,000.00 will be used

to fund education and training or other materials and supplies for officers assigned to drug enforcement activities, and \$10,000.00 will be available for equipment which will support front line enforcement.

FISCAL IMPACT:

A total of \$46,000.00 is available for appropriation in the Asset Seizure Fund. Funding is available for appropriation as recommended in the attached BA 14-06. These funds are restricted in use for expenditures related to the enhancement of drug enforcement activities. The appropriation request as proposed in the attached budget amendment complies with the intended purposes for the utilization of asset seizure funds.
