# SPECIAL MEETING MINUTES - October 16, 2013

#### **CALL TO ORDER:**

#### **PUBLIC COMMENTS**

Rick Piercy, Lewis Center, requested that a Temporary Certificate of Occupancy for the gymnasium at the Lewis Center be granted. He commented on the efforts of the Lewis Center to partner with the Town of Apple Valley and the community for the betterment of our Town. He stated that when the Town was incorporated, the community had two options in which to create development and they elected to go with the Town of Apple Valley for business development. He commented on the amount of funding that the Lewis Center has spent on business development.

Mr. Piercy commented on the design plans that have been completed for the required stop light at Tuscola Road along with the modifications as requested by the project engineers. He said that they are still in the approval stage of that phase of the project. He stated that he believes the stop light is an important asset, but did not feel that the gymnasium would generate any new traffic. He respectfully requested that the Lewis Center be granted a temporary Certificate of Occupancy and stated that no new students would be housed in the new area until the stop light is functioning.
