RECOMMENDED ACTION:

Adopt Resolution No. 2013-42 reciting the fact of the election and such other matters provided by law for Measure D.

SUMMARY:

With the consolidation of the Town of Apple Valley, Special Municipal Election, the Town of Apple Valley Town Council authorized the San Bernardino County, Election Office of the Registrar of Voters, to canvass the returns of the election for Measure D as originally adopted in Resolution No. 2013-33 on August 13, 2013.

The Elections Office of the County Registrar of Voters has certified the results of the election for Measure D. Measure D passed by a vote of 58.59% in favor to 41.41% against. The detailed results are attached and made a part hereof as Exhibit "A" to subject Resolution No. 2013-42.

At this point, the Council's last act with respect to the Measure D election is to acknowledge and certify the results of the election by adoption of attached Resolution No. 2013-42. Under Election Code Section 9217, Measure D will become effective 10 days after Council adoption of this Resolution.

RESOLUTION NO. 2013-42

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF APPLE VALLEY, CALIFORNIA, RECITING THE FACT OF THE SPECIAL MUNICIPAL ELECTION HELD ON NOVEMBER 19, 2013 DECLARING THE RESULT AND SUCH OTHER MATTERS AS PROVIDED BY LAW.

WHEREAS, a Special Municipal Election was held and conducted in the Town of Apple Valley, California, on Tuesday, November 19, 2013, as required by law; and

WHEREAS, notice of the election was given in time, form and manner as provided by law; that voting precincts were properly established; that election officers were appointed and that in all respects the election was held and conducted and the votes were cast, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Election Code of the State of California for the holding of elections in general law cities; and

WHEREAS, pursuant to Resolution No. 2013-33 adopted August 13, 2013, the County Elections Department canvassed the returns of the election and has certified the results to this Town Council, the results are received, attached and made a part hereof as "Exhibit A".

NOW THEREFORE, THE TOWN COUNCIL OF THE TOWN OF APPLE VALLEY, CALIFORNIA DOES RESOLVE, DECLARE, DETERMINE AND ORDER AS FOLLOWS:

SECTION 1. That the whole number of ballots cast in the Town except vote by mail ballots was 2,659. That the whole number of vote by mail ballots cast in the Town was 7,987. That a total number of 10,646 ballots were cast in the Town;

SECTION 2. That the Special Municipal Election was held for the purpose of submitting the following Measure, Measure D, to the qualified voters of the Town of Apple Valley:

MEASURE D

"Shall a General Plan Amendment be adopted, and shall Chapter 9.40 be repealed and Chapter 9.41 be added to the Town Development Code to enact the "Dale Evans Parkway Commercial Specific Plan" in order to allow a proposed commercial development in the Town of Apple Valley located on approximately 30 acres of undeveloped property north of Happy Trails Highway (SR-18), at the southeasterly corner of the intersection of Dale Evans Parkway and Thunderbird Road?"

SECTION 3. That the number of votes given at each precinct and the number of votes given in the Town, for and against the measure, is attached as Exhibit A.

SECTION 4. The Town Council does declare and determine that: As a result of the election, a majority of the voters voting on Measure D did cast a vote in support of the Measure, that Measure D was approved, by the voters and shall be deemed adopted and ratified
SECTION 5. The Town Clerk shall enter into the records of the Town Council a statement of the results of the election, showing: (1) The whole number of votes cast in the Town; (2) The Measure voted upon (Measure D); (3) The number of votes given at each precinct for and against Measure D; and (4) The total number of votes given for and against Measure D.
SECTION 6. That the Town Clerk shall certify to the passage and adoption of this resolution and enter it into the book of original resolutions.
