RECOMMENDED ACTION:

That the Town Council establish November 18, 2014, at 6:30 p.m., as the date and time certain, for the purpose of conducting the first of two (2) Community Development Block Grant (CDBG) and HOME Investment Partnerships Programs (HOME) public hearings necessary to develop the Town's Consolidated Plan - Fourth Year Action Plan for FY 2015-2016.

SUMMARY:

The Code of Federal Regulations regarding the Consolidated Plan requires a minimum of two (2) public hearings prior to submitting the Town's Consolidated Plan to the U.S. Department of Housing and Urban Development (HUD). The first of these public hearings should be conducted for the purpose of soliciting public input in the development of the Fourth-Year Action Plan. The Action Plan is the annual planning component of the Consolidated Plan and will determine the specific use of CDBG and HOME funds for the 2015-2016 program year. A second public hearing will be conducted on April 28, 2015 for the purpose of receiving the Community Development Citizen Advisory Committee (CDCAC) funding recommendations and public input regarding such recommendations.

It has been the practice of the Town Council to establish funding priorities for the next program year shortly after receiving public input at the first public hearing. Funding priorities will be set at the December 9, 2014 Town Council meeting. The established funding priorities provide guidance for the preparation and approval of CDBG proposals. The CDBG Technical Workshop to be held on November 25, 2014 will provide a forum to assist applicants in the development of their applications/proposals.
