#### **RECOMMENDED ACTION:**

That the Town Council adopt Resolution 2015-36, "A Resolution of the Town Council of the Town of Apple Valley establishing the intersection of Apple Valley Road and Del Oro Road as a three-way STOP intersection."

#### SUMMARY:

Staff received a request to investigate the intersection of Apple Valley Road and Del Oro Road to determine if a three-way stop is warranted. Currently, there is a STOP sign Del Oro Road on the east leg at Apple Valley.

Staff performed a traffic engineering investigation, which included an evaluation of past records of vehicle conflict, traffic volumes, and a field review of the intersection. The recommendation is supported by an Engineering Intersection Analysis by Mr. Jack Rydell, P.E., T.E., PTOE.

#### Recommendation by Staff


Staff recommends that three-way STOP controls be installed at the intersection of Apple Valley Road and Del Oro Road.

#### Fiscal Impact

The installation of two (2) large stop signs, two (2) advance stop-ahead warning signs, thermo stop stencils and limit lines, rumble strips, and temporary flashing beacons and flags have an estimated cost of \$6,000.00. Funding for this installation is provided within the approved 2015-2016 Street Maintenance Fund budget.

### **RESOLUTION NO. 2015-36**

## A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF APPLE VALLEY ESTABLISHING THE INTERSECTION OF APPLE VALLEY ROAD AND DEL ORO ROAD AS A THREE-WAY STOP INTERSECTION

WHEREAS, a traffic engineering investigation has determined that establishing the intersection of Apple Valley Road and Del Oro Road as a three-way STOP intersection is warranted in accordance with Section 52.0111 of the San Bernardino County Code as adopted by the Town of Apple Valley.

# NOW THEREFORE, THE TOWN COUNCIL OF THE TOWN OF APPLE VALLEY DOES RESOLVE AND ORDER AS FOLLOWS:

Section 1: Approves and establishes the intersection of Apple Valley Road and Del Oro Road as a three-way STOP intersection.

Section 2: Authorizes and directs the Town Manager to cause additional STOP signs to be placed on Apple Valley Road and Del Oro Road.
