RECOMMENDED ACTION:

For good cause shown, and finding a waiver will serve a public purpose, approve the waiver of the Facility Rental Fee of \$907.00.

SUMMARY:

No Drugs America is requesting use of the Civic Center Amphitheatre on April 30, 2016, in order to provide information to the youths in the community about the dangers of illegal drugs. There will be up to thirty (30) vendors from behavioral health and law enforcement agencies. They anticipate reaching out to 500 – 1000 youths and their family members. The organization will still be required to provide a Certificate of Insurance and submit a completed Facility Use Agreement for approval through the Park & Recreation Department.

BACKGROUND:

On August 14, 2001, the Town Council adopted a policy stating fees can be administratively waived for a local public agency, a utility company or service district, or a similar entity providing an essential service to the general community, whereas, non-profit requests for fee waivers must go before the Town Council for consideration.

FISCAL IMPACT:

Although there is not an ongoing demand that is displaced with the request on this particular day, the waiving of these fees will result in the loss of potential revenue in the amount of \$907.00.
