John Brown, Town Attorney, introduced the process that will be taken for discussion and presentation of this item.

Mark Easter, Best, Best and Krieger, discussed the legalities associated with this item and the findings that would need to be made in order to adopt the resolution.

Brad Miller, Town Engineer, presented the staff report as filed with the Town Clerk.

Council Member Bishop asked for clarification from Mr. Miller that concrete would be used for the proposed trail.

Mayor Stanton opened the public hearing at 7:45 p.m.

Gary Ledford, Property Owner, presented a PowerPoint presentation for the benefit of the Town Council illustrating his objection to the proposed resolution.

Mayor Pro Tem Nassif asked questions of Mr. Ledford regarding proposed uses for the property in question.

Sherwood Beck, Vice President, Jess Ranch Homeowner's Association, stated that he was in support of the proposed project.

Denney Strong, Apple Valley, commented on the proposed project. He recommended the project be completed; however, he wanted to ensure that the property rights of the owner were protected.

Rusty Green, Apple Valley, recommended the project be completed.

Thurston Smith, Apple Valley, recommended that all parties involved discuss the matter for possible resolution.

Mr. Ledford noted that he would be out of Town for three (3) weeks, but would be willing to meet and discuss this matter with staff upon his return.

Discussion ensued regarding whether or not any other options or opportunities were available to possibly mitigate this matter.

Mr. Miller explained for the benefit of the Town Council that the Town had diligently pursued discussions and negotiations with Mr. Ledford and his representatives to come up with solutions to acquire the property.

Mr. Easter addressed Section 8 of the proposed Resolution of Necessity and how the process would work should the Town Council decide to adopt the resolution tonight. In addition, Mr. Easter briefly described each step for legal possession of the property interest to be acquired and the Town's certification deadline.

#### **BUSINESS OF THE COUNCIL**

12. Security Enhancing Measures for the Town of Apple Valley Council Chamber and Town Hall

Captain Lana Tomlin, Apple Valley Police Department, presented the report as filed with the Town Clerk.

Mayor Stanton recommended a cost analysis be conducted based on Captain Tomlin's recommendation.

Tom Piper, Apple Valley, believed that this type of security measure was not necessary in the Chamber.

Discussion ensued regarding possible security measures that could be taken to enhance the safety and welfare of individuals in the Council Chambers.

It was the consensus of the Town Council to direct the Apple Valley Police Department to develop a plan based on the recommendations of the Town Council and bring back the matter to a future meeting for further review and approval.

# TOWN MANAGER'S COMMENTS & LEGISLATIVE UPDATE

Frank Robinson, Town Manager, stated that the Senate passed Assembly Bill 21 dealing with Medical Marijuana Cultivation Licenses. Following their action last year, many cities passed their own local ordinances to maintain control. The legislature now feels that action was premature and should be addressed. The League of California Cities supports the legislature but still advises cities to pass their ordinances as soon as possible to maintain local control.

Secondly, the Town conducted its first Shred Fest this year allowing residents to bring boxes of old documents to destroy. Mr. Joseph Moon, Environmental and Transit Services Manager, is in charge of this program and provided an update that 385 boxes of documents were shred with 148 participants.
