### RECOMMENDED ACTION:

Approve the donation of \$2,500.00 in support of the Victor Valley Bicycle Tour, planned for Saturday, October 29, 2016.

### SUMMARY:

Thurston “Smitty” Smith, a board member for the Victor Valley Bicycle Tour, has requested \$2,500.00 in support for their 2016 event. The majority of proceeds from this year’s event will be used to promote bicycle safety, as well as raise awareness of the new “Give ‘em 3” bicycle law, which requires drivers to give riders at least three feet of clearance when sharing the road.

### BACKGROUND:

The Town of Apple Valley has provided various levels of support to this event, in its different iterations, over the last few years. Financial donations, as well as in-kind support through the provision of rider aid stations and logistical support from Town staff has helped bring this popular sport to Apple Valley and the entire region.

### FISCAL IMPACT:


