RECOMMENDED ACTION:

That the Town Council establish December 13, 2016, at 6:30 p.m., as the date and time certain for the purpose of conducting the first of two (2) public hearings related to the Community Development Block Grant (CDBG) and HOME Investment Partnerships (HOME) Programs necessary to develop the Town's 2017-21 Consolidated Plan and 2017-18 First Year Action Plan.

SUMMARY:

The Code of Federal Regulations regarding the Consolidated Plan requires a minimum of two (2) public hearings prior to submitting the Town's Consolidated Plan to the U.S. Department of Housing and Urban Development (HUD). The Town and the City of Victorville will conduct public meetings during November to identify barriers to fair housing and equal opportunity as well as determine goals and strategies for addressing those issues.

The first public hearing will be conducted for the purpose of soliciting public input to prioritize needs identified in the public meetings for the First-Year Action Plan. The Action Plan is the annual planning component of the Consolidated Plan and will determine the specific use of CDBG and HOME funds for the 2017-18 program year. It has been the practice of the Town Council to establish funding priorities for the next program year shortly after receiving public input at the first public hearing. Funding priorities will be set at the January 10, 2017, Town Council meeting. The established funding priorities provide guidance for the scoring and approval of CDBG proposals. The CDBG Technical

Workshop to be held on November 17, 2017 and will provide technical assistance to applicants in the development of their applications/proposals.

A second public hearing will be conducted on April 25, 2017, for the purpose of receiving the Community Development Citizen Advisory Committee (CDCAC) funding recommendations and public input.
