#### **RECOMMENDED ACTION:**

That the Town Council receive, ratify and file the Commercial Warrants and Wire Transfer Schedules as presented.

#### **SUMMARY:**

Commercial warrants were issued from January 1 through January 31, 2017 in the amount of \$3,714,167.96 covering issued warrant #'s 120701 – 121127. Also, wire transfers were made from January 1 through January 31, 2017 in the amount of \$32,628.50.

The claims and/or demands covered by the attached list of warrants and wire transfers were audited as to the accuracy and availability of funds for payment thereof and said claims and/or demands are accurate and the funds were available for payment thereof.

#### **BACKGROUND:**
