That the Town Council receive, ratify and file the Commercial Warrants and Wire Transfer Schedules as presented.

SUMMARY:

Commercial warrants were issued from February 1 through February 28, 2017, in the amount of \$3,610,008.70 covering issued warrant #'s 121128 – 121521. Also, wire transfers were made from February 1 through February 28, 2017, in the amount of \$518,697.56.

The claims and/or demands covered by the attached list of warrants and wire transfers were audited as to the accuracy and availability of funds for payment thereof and said claims and/or demands are accurate and the funds were available for payment thereof.

BACKGROUND:

Pursuant to the Town's Municipal Code the attached demands were presented by the departments, audited by the Finance Department and subsequent warrants/wire transfers were issued.
