- b. The power line will be operated solely in conjunction with the CEMEX Facility, and will be removed or disconnected upon completion of service to the CEMEX Facility.
- c. The power line will be operated adjacent to an existing CEMEX private gated road, and adjacent to CEMEX'S privately owned railroad.
