PUBLIC COMMENTS

Richard Rorex, Apple Valley, commented on the total cost of providing water to the community and the amount of funds that have been spent by both Liberty Utilities and the Town of Apple Valley in their quest for the water agency.

Pat Hanson, Apple Valley, commented on her support for Liberty Utilities.

Christina Burton, Apple Valley, commented on what she believed were foreseen safety problems on the bridge. She then spoke of her belief that the Town of Apple Valley hired an Economist who has not fully vetted all the information associated with Measure F. She also spoke on the lack of information published to the public regarding Apple Valley Choice Energy.

Jim Blackburn, Apple Valley, commented on the use of marijuana and the need for the Town Council to support the use in the community.

Tom Piper, Apple Valley, commented on street racing in Apple Valley.

Diana Carloni O'Malley, Apple Valley, disputed statements that she believed were falsely made by the Yes on Measure F Campaign Committee.

Al Rice, Apple Valley, commented on the robocalls that he has received regarding Measure F. He also commented on the analysis conducted by students at the University of California Riverside which he believed did not account for all the information associated with Measure F.

8. Economic Analysis of Water Acquisition Efforts – Dr. Christopher Thornberg, Ph.D., Beacon Economics

Marc Puckett, Assistant Town Manager, introduced Dr. Christopher Thornberg, who will present an external analysis of the water acquisition efforts.

Dr. Christopher Thornberg, presented a powerpoint presentation that debated whether or not purchasing the local water agency from the current owner was a good financial move for the Town of Apple Valley. In his analysis, he reviewed financial modelling, the purchase price, interest rates, increases, net revenue analysis, capital expenses and the Town's ability to run the utility company. During his analysis, he critiqued estimates presented by Economist John Husing.

The Town Council Members each thanked Dr. Thornberg for his honest unbiased opinion reviewing the evidence of the utility purchase plan.

Mayor Pro Tem Bishop asked Dr. Thornberg for his opinion as to why the current utility provider had not filed the required reports as mandated.

Dr. Thornberg responded stating that the lack of compliance is due to either basic incompetence or a desire not to share the information.

Diana Carloni O'Malley, disputed statements made by Dr. Thornberg and his overall analysis of the Town's purchase of Liberty Utilities.
