RECOMMENDED ACTION:

- 1) Award a purchase contract to Haaker Equipment Company for the purchase of a street sweeper in the amount of \$286,333.74.
- 2) Approve Budget Amendment Number 2018-01.

SUMMARY:

The Town received a quote from Haaker Equipment Company (Haaker) in the amount of \$286,333.74 for a new street sweeper. This is the equivalent model to the old sweeper manufactured by Elgin. Haaker is the local territory sales and service distributor of Elgin sweepers and this pricing is based on the NJPA cooperative purchase agreement. Haaker is supposed to take delivery of this sweeper the first week in July and could deliver it to the Town by the end of July.

BACKGROUND:

The Town's street sweeper caught on fire on May 22, 2017 and is a total loss. The Town only had one street sweeper and needs to purchase a new one to replace it in order to maintain our streets within the Town. The sweeper was originally purchased from Haaker Equipment in 2006 and the Town is very pleased being Haaker has provided excellent customer service with training, service and factory replacement parts for the sweeper.

FISCAL IMPACT:

Funding for the purchase of the street sweeper will be provided from the Street Maintenance Fund, account number 2010-5010-9120-0000. This appropriation will be primarily offset by insurance proceeds received for the replacement of the existing sweeper. The remaining funding will be appropriated from the Street Maintenance Fund fund balance. Approval of Budget Amendment Number 2018-01.
