Subject: AWARD A PURCHASE CONTRACT TO HAAKER EQUIPMENT COMPANY FOR THE PURCHASE OF A PATCH TRUCK

RECOMMENDED ACTION:

Award a purchase contract to Haaker Equipment Company for the purchase of a patch truck in the amount of \$174,986.00.

SUMMARY:

The Town received a quote from Haaker Equipment Company (Haaker) in the amount of \$174,986.00 for a new patch truck. Haaker's pricing is based on the NJPA Cooperative Purchasing Agreement. The new patch truck provides all the tools and materials necessary for a two-person crew to make effective asphalt repairs eliminating several types of equipment which would now be condensed into one truck. This results in less intensive labor and minimizes the amount of equipment used in traffic areas. The design of the truck also provides improved ergonomics for employees during application of materials and storage of mechanical equipment used for breaking and compacting asphalt.

BACKGROUND:

The Town's current patch truck is outdated and is unable to hold a large quantity of asphalt. This new patch truck is much more efficient, allowing for asphalt storage that could be used the following day. Currently, staff must travel to the asphalt plant in Oro

Grande each morning to pick up asphalt because the current truck does not hold enough. The Town's current patch truck is only a 1 ½ ton truck and this new one is a 6-ton truck. The Town's street sweeper was also purchased from Haaker Equipment and the Town has been very pleased with their excellent customer service and the ability to obtain service and parts from them when necessary.

FISCAL IMPACT:

Funding for the purchase of the patch truck is budgeted in the Street Maintenance Fund, Account Number 2010-5010-9120-0000.
