RECOMMENDED ACTION:

That the Town Council set December 12, 2017, at 6:30 p.m., as the date and time for conducting the first of two public hearings related to the Community Development Block Grant (CDBG) and HOME Investment Partnerships (HOME) Programs to develop the Town's 2018-19 Second Year Action Plan in conformance with the 2017-21 Consolidated Plan.

SUMMARY:

Federal regulations require a minimum of two public hearings prior to submitting the Town's Action Plan to the U.S. Department of Housing and Urban Development (HUD). The Town and City of Victorville conducted public workshops on November 1 and 2, respectively, to discuss the community needs identified in the Consolidated Plan and receive input as to the desired focus and priorities for the upcoming 2018-19 Action Plan funding allocations. The first public hearing, on December 12, will solicit additional public input to prioritize needs identified in the public workshops.

BACKGROUND:

The Action Plan is the annual planning component of the Consolidated Plan and will determine the specific use of CDBG and HOME funds for the 2018-19 program year. It has been the practice of the Town Council to establish funding priorities for the next program year shortly after receiving public input at the first public hearing. Funding priorities will be approved based upon the results of a community needs survey, two public workshops, and two public hearings. The established funding priorities provide guidance for the scoring and approval of CDBG/ HOME proposals. The CDBG

Technical Workshop to be held on December 19, 2017 will provide technical assistance to applicants in the development of their applications/proposals.

A second and final public hearing will be conducted on April 24, 2018, to receive the Community Development Citizen Advisory Committee (CDCAC) funding recommendations and public input.
