## RECOMMENDED ACTION:

That the Town Council receive, ratify, and file the Commercial Warrants and Wire Transfer Schedules as presented.

## SUMMARY:

Commercial warrants were issued from November 1 through November 30, 2017 in the amount of \$5,253,973.57 covering issued warrant #'s 125534 – 126050. Also, wire transfers were made from November 1 through November 30, 2017 in the amount of \$346,949.82.
