<b>PUBLIC COMMENTS</b>

Gloria Gilmore, Apple Valley, expressed concern regarding the lack of street lights in the Town of Apple Valley.

Regina Longona, Apple Valley, also expressed concern regarding the lack of lights and speed limits in the community, as well as, the lack of stop signs. She commented on the numerous deaths that have occurred that she believes is a result of these issues. She respectfully requested that the Town Council consider having the local areas surveyed in order to reassess the areas.

Kelly Maxwell, representing Orenda Veterans Project, commented on the project and the programs it offers. He also commented on the various organizations that help support the project by offering free programs. He thanked Mr. Jeff Collins for his assistance with the program. He also commented on the various grants they have received including \$25,000.00 from the Veteran's Administration.

Ross Sevy, District Director for Assemblyman Jay Obernolte, introduced himself to the Town Council and the community. He stated that the Assemblyman's local office is open and he and his staff are ready to assist the public as needed.

Tom Piper, Apple Valley, commented on the success of residents in the Town of Apple Valley.

Tony Penna, Apple Valley Ranchos Water Agency, provided the Town Council with a brief update regarding the various drought conditions throughout the state. He stated that Apple Valley Ranchos Water Agency continues with drought and conservation efforts. He also announced the Mojave Water Agency's Cash for Grass program will begin on February 1, 2015.

Eric Larsen, Apple Valley Ranchos Water Agency, provided the Town Council with additional information on the Dashboard Report provided this evening, as it pertains to the unaccountable water for 2014. He also commented on Apple Valley Ranchos Water Agency's first project for 2015, to replace old water mains in Apple Valley.

Al Rice, Apple Valley, expressed concern regarding the Town's noticing practices.

Allen Jones, representing Veterans with Injuries, proposed to the Town using Civic Center Park for a fundraiser during Labor Day to assist the Veterans in the community.

Phillip Rivera, Apple Valley, commented on the illegal off-road traffic near his residence. He stated that AQMD put a fence around the area that was used to prevent off-roading; however he has been told that the fence will be removed due to the Town's Municipal Code. He respectfully requested that this issue be addressed.

Frank Robinson, Town Manager, commented on previous discussions regarding this issue.

John Laraway, Apple Valley, spoke regarding the Apple Valley water issue. He recommended that a bond not be used to purchase the water company.

**13. A Request to Consider an Amendment to Title 9 “Development Code” of the Town of Apple Valley Municipal Code by Modifying Section 9.74.160 “Temporary Real Estate Signs” of Chapter 9.74 “Signs and Advertising Displays”**

Mayor Cusack opened the public hearing at 8:27 p.m.

Pam Cupp, Associate Planner, presented the staff report as filed with the Town Clerk. She confirmed that members of the real estate community were present to discuss this item at the Planning Commission Meeting. She also stated that adoption of this ordinance would allow the Town to be industry standard.

Where it can be seen with certainty that there is no possibility that the activity in question, the proposed Code Amendment, may have a significant effect on the environment, the activity is not subject to CEQA.
2. **Find** the facts presented within the staff report support the required Findings for approval of an amendment to the Development Code, and adopt the Findings.
3. **Find** that the proposed Town Council Ordinance is consistent with the Goals and Objectives of the adopted Town of Apple Valley General Plan and that it is necessary to preserve the health, safety, and general welfare of the citizens of Apple Valley.
4. **Move** to waive the reading of Ordinance No. 466, in its entirety, and read by title only.

### **BUSINESS OF THE COUNCIL**

**14. Adopt Resolution No. 2015-02, A Resolution of the Town Council of the Town of Apple Valley, California - Results of Painted on Wall Sign Survey**

Pam Cupp, Associate Planner, presented the staff report as filed with the Town Clerk.

Council Member Nassif questioned whether or not signs would need to be changed to current standards if changes to the name of the business were made.

Discussion ensued regarding whether or not existing signs could be grandfathered in if the name of the business was changed.

It was the consensus of the Town Council, based on statements by the Town Attorney, that the resolution be amended to include any modification to copy.

## 15. Synthetic Drugs Update

Captain Lana Tomlin, Apple Valley Sheriff's Department presented an update on Synthetic Drugs.

The Town Council discussed whether or not the Town of Apple Valley should adopt an ordinance prohibiting synthetic drugs at this time.

John Brown, Town Attorney, questioned whether or not the state would consider an ordinance regarding possession to be constitutional. He believed that if possession is a problem, then perhaps the state of California should amend its Health and Safety Code to include possession. He stated he would bring back to Council, for their consideration, more information as it pertains to this issue.

This was a receive and file item only.

### TOWN MANAGER'S COMMENTS & LEGISLATIVE UPDATE

Jim Andersen, Code Enforcement Manager, commented on the success of Tire Amnesty Day. He stated that in total, they have received over 100,000 tires since the inception of this program. He also commented on the Code Enforcement year-end report that is available to the public.

Joseph Moon, Environment and Transit Services Manager, commented on the new ads for sale for bus shelters. He stated that to date, they have received over \$10,000 for shelter ads. He also commented on new shelters installed in the community and also the inclusion of solar lighting to many of the shelters.

Orlando Acevedo, Economic Development Manager, commented on Apple Valley being listed #68 for "Best Cities" to raise a family. He also spoke of additional rankings where Apple Valley has ranked high. He stated that next month, he will be bringing an update to the Town Council on Economic Development in the Town.

Frank Robinson, Town Manager, announced he will be attending the City Manager's Department Meeting tomorrow, along with Assistant Town Managers Lori Lamson and Marc Puckett. He stated that the event is hosted by the League of California Cities.


## 16. Closed Session
