RECOMMENDED ACTION:

It is recommended that the Town Council:

AND KEY RESOURCES

- A. Approve receipt of the Homeland Security Grant funding in the amount of \$22,779 and adopt Budget Amendment Number 18-12 appropriating grant funding; and
- B. Authorize the Town Manager and/or Assistant Town Manger to execute the agreement with the Homeland Security Grant Program through the Governor's Office of Emergency Services to distribute the funds to Vigilant Solutions for the purchase of automated license plate readers.

SUMMARY AND BACKGROUND:

The Town has received funds from the Homeland Security Grant Program over the last several years. The funds are distributed to various law enforcement jurisdictions based upon population. The funds are intended to be used to prevent, protect against, mitigate, respond to and recover from threats, hazards, and acts of terrorism. The funds are distributed through the Governor's Office of Emergency Services. Based upon the projected allocations outlined in the 2017 Homeland Security Grant funding, the Town has been allotted grand funding in the amount of \$22,779.

In considering various uses of the grant funding, protecting our Town and its resources, which constitute the citizens, dwellings and businesses, is a key factor. Being able to share data for public safety is also an important factor. The Sheriff's Department is currently using Automated License Plate Readers (ALPR) throughout the department.

ALPR's capture license plate images from high resolution cameras. The ALPR's can be strategically placed in areas of high traffic, affixed to secured objects, such as light poles or traffic control poles or the cameras can also be made mobile by mounting them to a vehicle or a trailer.

The ALPR's scan the surrounding area for license plates. The system captures color images of each vehicle as well as an infrared image of the license plate, which is converted into a text file that is then checked against an onboard database. In the event of a "hit," an audible and visual alert notifies the officer and/or dispatcher. Display of the "hit" event includes the plate image, date and time stamp, vehicle color overview image, GPS coordinates and relevant database information pertaining to the nature of the hit.

The San Bernardino County Sheriff's Department (TSD) has already installed large database servers in our server room on our Local Area Network (LAN). The servers are supported and maintained by our TSD staff members including Automated Systems Analyst(s) and Database Administrators. The data will be archived, providing access to investigators and field personnel to the database for retrieval of pertinent information for investigative purposes. Regular database updates will be received every four (4) hours by way of direct File Transfer Process (FTP) from the Department of Justice (DOJ) for the National Crime Information Center (NCIC).

The Town of Apple Valley contracts with the Sheriff for police services. After extensive research and testing of LPR vendors, the Sheriff selected a vendor, Vigilant Solutions, for county wide LPR police data solutions. The network and infrastructure are already in place and is currently passing Sheriff Data to a hosted cloud within a secure data center. All data stored and maintained can easily be shared between all sheriff stations and other municipalities within our county, and/or throughout the state. Vigilant Solutions is already deployed in other stations within the Sheriff's Department, including other contract cities such as Rancho Cucamonga, Big Bear, Hesperia and Highland, just to name a few.

In order to use the current Sheriff network for LPR data, to receive support from the Sheriff on any LPR project, the standardized vendor selected by them must be used, as they will not support various platforms and/or systems.

FISCAL IMPACT:

None. The allotted grant funding will be sufficient for the cost ALPR system installed by Vigilant Solutions.

CONCLUSION:

The staff recommended approval by Town Council of Budget Amendment Number 18-12 to appropriate the grant funding, and authorization of appropriate staff to execute the Vigilant Solutions agreement, will allow for the installation of an ALPR system to enhance protection and share data.
