#### **RECOMMENDED ACTION:**

Approve a contract change order to VSS International, Inc., amending the Paving 17-18 - Project No. 2018-01 scope of work, subject to "Approval as to Form" by the Town Attorney and "Approval as to Content" by the Town Manager.

### SUMMARY:

On April 24, 2018, the Town awarded the Paving 17-18 Project No. 2018-01 contract to VSS International, Inc. This project includes providing necessary labor, equipment and materials for the application of microsurface, chip seal, and cape seal on various streets within the Town of Apple Valley.

Staff recommends that the Town Council approve Change Order No. 002, which will modify the scope of work, converting the roadway segments that had been designated to receive a chip seal application, upgrading them to a cape seal. The affected roadways will be added to the total area receiving cape seal, at the approved contract unit price for cape seal application.

#### **BACKGROUND:**

As part of the Town's annual paving priorities, several pavement rehabilitation strategies were utilized, depending on the condition of the subject roadway. Roadways which received the chip seal and cape seal applications were then evaluated by Engineering Department staff to determine their respective effectiveness. After evaluation, staff

recommends that the chip seal roadway segments, (chip seal being the first stage in a cape seal application), be elevated to the cape seal strategy. The current contractor is willing to extend the approved unit price for cape seal application to include the segments originally specified to receive chip seal. This change order will modify the total area specified to receive cape seal, and increase the total contract by the difference between the two paving strategies.

#### **FISCAL IMPACT:**

Funding for this project has been appropriated in the Town Council approved 2017-2018 Capital Improvement Projects Budget using Measure I funds, and any additional funding needed to cover the increase in cost is proposed to be allocated from the upcoming 2018-2019 Annual PMS Project, subject to Town Council approval.
