Al Rice, Apple Valley, expressed concern regarding the lack of signature approval by a manager noted on documents presented to the Town Council for approval. He believed that this was warranted.

Dan Harley, Apple Valley, commented on the proposed closure of Virginia Park.

Bill Inger, Apple Valley, recommended that an easier method be developed to allow the public to place items on the agenda.

Matthew Rutledge, Apple Valley, expressed concern about an incident that occurred with the Sheriff's Department. He believed that more sheriffs were needed to patrol the community in the evening hours so that a quicker response time is received.

#### PUBLIC HEARINGS

## 7. Appeal No. 2018-003 – An Appeal of the Planning Commission's Approvals of Conditional Use Permit No. 2017-006 and Deviation No. 2018-003 for a Proposed Sixty (60)-Foot Tall Wireless Telecommunication Facility within Mendel Park

Mayor Bishop opened the public hearing at 7:14 p.m.

Carol Miller, Assistant Director of Community Development, presented the staff report as filed by the Town Clerk.

Council Member Nassif asked questions regarding the process for an applicant constructing a tower.

Council Member Stanton asked for clarification on the request for the deviation.

Mayor Pro Tem Cusack questioned the need for cell towers in the community. He explained that the proposed towers are low frequency and deemed safe.

Mayor Bishop commented that this is a 30-year agreement. He questioned if the applicant would be responsible for removal of the site if it is no longer in use.

Linda Repp, Appellant, commented on the radiation that she believes will be emitted from the towers along with other materials that can cause harm to children.

Cameron Dancho, representing Verizon Wireless, stated that Verizon is in compliance with FCC on this project and he also discussed the durability of the structure and routine maintenance that would be conducted. He said that the proposed location is the preferred location for this tower. Al Rice, Apple Valley, believed that there would be problems with this location. He commented on the process to place frequency underground making towers obsolete.

Lawrence McCarthy, Apple Valley, stated that he has researched the danger of electromagnetic beams and the danger that they pose on individuals.

J. Valenzuela, Apple Valley, spoke in support of the appeal. She believed that the school children were required by law to attend school and would be forced to endure magnetic beams that could cause harm to students.

Linda Repp, Appellant, believed that additional notices should be provided to residents outside the mandated requirement for noticing. She noted that schools in the Los Angeles area have banned towers near school sites.

There being no additional requests to speak, Mayor Bishop closed the public hearing at 7:50 p.m.

Discussion ensued regarding the comments made by the appellant and the applicant in reference to placement of the cell tower.

Thomas Rice, Town Attorney, noted for the record that the Town Council could not consider radio frequency when making its determination. He also noted that case law states that towers in parks do not take away from the aesthetics of the park.

Motion by Council Member Stanton, seconded by Council Member Nassif, to adopt Town Council Resolution No. 2018-28, which denies the appeal of the Planning Commission approval of Conditional Use Permit No. 2017-006 and Deviation No. 2018-003 subject to the conditions of approval.

#### 8. A Resolution of the Town Council of the Town of Apple Valley, California, Approving Budget Appropriations and Adopting the Operating and Capital Improvement Budget for All Funds for Fiscal Year 2018-2019

Mayor Bishop opened the public hearing at 8:10 p.m.

Kofi Antobam, Director of Finance, presented the staff report as filed with the Town Clerk.

Doug Robertson, Town Manager, commented on the proposed closure of Virginia Park and the desire to continue honoring her legacy through other methods.

Council Member Nassif commented on the use of Virginia Park for ball practice and indicated that his Park Commissioner was concerned that the recommendation to close the park was not presented to the Park and Recreation Commission for their review and analysis on the impact of its closure.

Al Rice, Apple Valley, asked questions regarding the amount of funds allocated for the Property Business Improvement District, the Sheriff's Contract and the water acquisition.

Vicki Brown, Apple Valley, briefed the Town Council on the history of Virginia Park.

David Lisberg, Sun City, asked questions about the proposed budget. He also stated that he did not believe there was any allocation of funds listed for the water litigation.

Mr. Robertson answered questions that were presented by the public regarding the budget.

There being no additional requests to speak, Mayor Bishop closed the public hearing at 9:05 p.m.

Discussion ensued regarding the water costs at Virginia Park, potential revenues, expenditures and the potential need to reduce services as a cost saving measure.

Mayor Bishop encouraged staff, the family of Virginia and the water district to work together to honor the individual in which the Park was named.
