RECOMMENDED ACTION:

That the Town Council:

- A. Accept the work completed as part of the Paving 17-18 Project No. 2018-01 for a total contract cost of \$2,301,136.82
- B. Direct the Town Clerk to file the Notice of Completion for the contract work.
- C. Direct the Finance Director to release the retained funds 30 days after the Notice of Completion has been filed, provided no claims are filed against the contractor.

SUMMARY:

On April 24, 2018, the Town awarded a contract to VSS International, Inc. for the Paving 17-18 - Project No. 2018-01. The Project consisted of providing necessary labor, equipment and materials for the application of cape seal and microsurfacing on various streets within the Town of Apple Valley. A change order was issued to add an additional local area considered a priority by engineering staff. A second change order was issued to upgrade the resurfacing treatment for residential road segments from chip seal to cape seal.

FISCAL IMPACT:

The final construction costs for the project, under VSS International's contract, is \$2,301,136.82, and the project was completed within budget.
