PUBLIC HEARING NO. 1 (CONSOLIDATED PLAN – THIRD YEAR ACTION PLAN) – ESTABLISHING DATE AND TIME CERTAIN

#### **Summary Statement:**

The Code of Federal Regulations regarding the Consolidated Plan requires a minimum of two public hearings prior to submitting the Town's Consolidated Plan to the U.S. Department of Housing and Urban Development (HUD). The first of these public hearings should be conducted for the purpose of soliciting public input in the development of the Third-Year Action Plan. The Third-Year Action Plan is a major component of the Consolidated Plan and will determine the specific use of CDBG and HOME funds for the 2009-2010 program year. A second public hearing will be conducted on May 12, 2009 for the purpose of receiving the Community Development Citizen Advisory Committee (CDCAC) funding recommendations and public input regarding such recommendations.

It has been the practice of the Town Council to establish funding priorities for the next program year shortly after the first public hearing. The list of funding priorities is then provided to applicants during the Technical Workshop, a free workshop that is held to assist CDBG and HOME applicants with any questions regarding the development of their applications/proposals.

A copy of the tentative 2008-2009 Consolidated Plan Schedule is attached for your information. As such, staff recommends adoption of the form motion.

## **Recommended Action:**

That the Town Council establish October 14, 2008 at 6:30 p.m., as the date and time certain for the purpose of conducting the first of two Community Development Block Grant Program and HOME Investment Partnerships program public hearings necessary to develop the Town's Consolidated Plan – Third Year Action Plan.
