RECOMMENDED ACTION:

- A. Award a contract to VSS International, Inc. for Resurfacing 2019-01 - Project No. 2018-07 subject to “Approval as to Form” by the Town Attorney and “Approval as to Content” by the Town Manager;
- B. Approve Budget Amendment No. 2019-20

SUMMARY:

On March 7, 2019, the Town received and opened bids for the subject project. The Project generally consists of providing necessary labor, equipment and materials for the application of Cape Seal and Micro surface on local roads totaling approximately 15 miles within the Town of Apple Valley.

The bid results are as follows:

BACKGROUND:

As part of the Town’s annual paving priorities, staff evaluated the local roadways and determined priority areas in need of maintenance. The segments in this project primarily consist of VVTA bus routes that have not been resurfaced during recent projects.

The bid documents for the projects were reviewed by staff for accuracy and constructability. The bid documents and the authorization to advertise were approved by Town Council on February 12, 2019. Staff reviewed the bid submissions for completeness and considers VSS International to be a qualified, responsible and responsive bidder.

FISCAL IMPACT:

Funding for this project will come from a combination of LTF funds and Measure I. Budget Amendment No. 2019-20 allocates \$1,046,556.00 in LTF funds for the project with the balance coming from Measure I which was appropriated in the approved FY 2018-2019 annual budget.
