Mayor Cusack opened the public hearing at 6:47 p.m.

Sydnie Harris, Director of Finance, respectfully requested that this item be moved to later in the agenda. She explained that the consultant is in route to the meeting.

Mayor Cusack closed the public hearing at 6:47 p.m.

It was the consensus of the Town Council to move this item until later in the agenda.

12. Public Hearing #1 to Receive Public Comments on Transition to District-Based Elections Under the California Voting Rights Act

Mayor Cusack opened the public hearing at 6:48 p.m.

Thomas Rice, Town Attorney, presented the staff report as filed with the Town Clerk.

Richard Rorex, Apple Valley, expressed concern regarding moving to districts. He felt that forcing communities into districts to create "diversity" does not guarantee the results that they choose to correct. He stated that he supported candidates that supported the community and not themselves.

Tom Piper, Apple Valley, commented that he had made the suggestion for districts many years ago and believes we should move forward.

Roger LaPlante, Apple Valley, stated that there are already district boundaries for the school district. He believed it would save costs to utilize those boundaries with modifications for the Town of Apple Valley.

There being no additional requests to speak, Mayor Cusack closed the public hearing at 7:00 p.m.

Mayor Pro Tem Nassif questioned how the process for the workshops would take place and the options that would be provided to the public for their review.

Mr. Rice explained that many examples would be provided for members of the public and that samples of what other cities have implemented would be given for their information.

Council Member Bishop questioned, and Mr. Rice confirmed that Council appointees do not need to reside in the appointing Council Member districts.

Doug Robertson, Town Manager, commented on the release of the maps and the future meetings on this topic that will allow the public and Council sufficient time to review and ask questions on this matter.

This was a receive item only to accept input regarding the composition of the districts. There was no action taken.

11. A Resolution of the Town Council of The Town of Apple Valley Amending Apple Valley Choice Energy Customer Power Generation Rate Schedule

Mayor Cusack re-opened the public hearing at 7:07 p.m.

Sydnie Harris, Director of Finance, presented the staff report as filed with the Town Clerk.

Barbara Boswell, Consultant, stated that new time of use periods had been established and adopted by Southern California Edison and she explained that the change modifies the peak usage time. She respectfully requested that Apple Valley adopt the same rate schedule which will still offer the discount provided by Apple Valley Choice Energy.

Mayor Pro Tem Nassif questioned the proposed changes in peak times and generation rates.

Ms. Boswell explained the changes that will take place. She also noted that due to timing, there will be two additional modifications that will be brought back for Council consideration and approval.

There being no requests to speak, Mayor Cusack closed the public hearing at 7:15 p.m.

Sydnie Harris, Director of Finance, presented the staff report as filed with the Town Clerk. She provided a detailed PowerPoint presentation that illustrated revenues and expenditures for the first half of the fiscal year.

The Town Council Members asked clarification questions on the potential revenues anticipated before the end of the fiscal year and thanked Ms. Harris for her hard work on the budget process.

Doug Robertson, Town Manager, announced that the Town would be installing a new sound system for the Chambers that should be complete by April 23, 2019. He also clarified the concerns expressed by the public regarding the inability to build secondary structures on residential property. He confirmed that secondary structures can be built on homes less than an acre if they are connected to sewer.

Mr. Robertson also informed the public that manhole repair work would be taking place in the Stonebrook area. He noted that the repair work may cause some temporary odor in the area.
