RECOMMENDED ACTION

That the Town Council:

- A. Accept the work completed as part of the Resurfacing 2019-01 Project No. 2018-07 for a total contract cost of \$1,449,286.50.
- B. Direct the Town Clerk to file the Notice of Completion for the contract work.
- C. Direct the Finance Director to release the retained funds 30 days after the Notice of Completion has been filed, provided no claims are filed against the contractor.

BACKGROUND

The project consisted of providing the necessary labor, equipment and materials to resurface approximately 15 miles of road within the Town of Apple Valley, and all other tasks as specified in the plans and technical specifications, and as directed by the Town Engineer. The segments in this project primarily consist of VVTA bus routes that have not been resurfaced during recent projects. On April 23, 2019, council approved CCO1 adding the resurfacing of the existing Class I Bike Paths along Apple Valley Road and Yucca Loma Road to the project.

ANALYSIS

Engineering staff inspected the project area and deemed the work to be complete and acceptable.

FISCAL IMPACT

Funding for this project will come from a combination of Local Transportation Funds (LTF), Measure I, and a Transportation Development Act (TDA) Article 3 Grant. Budget Amendment No. 2019-20 allocated \$1,046,556.00 in LTF for the initial resurfacing portion of the project with the balance coming from Measure I which was appropriated in the approved FY 2018-2019 annual budget. The final cost for CCO1 is \$61,820 will be funded, in part, by a \$37,450 the TDA grant with the remaining \$24,370.39 coming from LTF funds.
