#### 1. Approval of the Parks and Recreation Minutes for August 1, 2019 Meeting

# 3. Resolution for the priority funding for identified projects using Quimby Funds for expansion of existing parks and development of new parks

Parks & Recreation Manager David C. Coleman advised the commission of the process the resolution will take to move forward with the Quimby Fund projects. He advised that the resolution will probably go to the Town Council for approval in November and he will advise the commission when it gets on the agenda. Vice-Chair Doran also advised the board of his priorities for Quimby fund projects since he was not able to attend the prior meeting.

#### 4. CDBG/Parks Project Update

Parks and Recreation Manager, David C. Coleman advised the commission of the Mendel Park restroom project status. The bids received were much higher than the original inhouse estimates. Since we will need to reject the bids and ultimately start over, he has decided to look at another restroom option that suits the needs of citizens better. He explained that the restroom and/or camera project should be completed the beginning of 2020.

#### PARK AND RECREATION COMMISSIONER COMMENTS

Vice-Chair Doran wanted additional information regarding the irrigation improvement project at James Woody Community Center. Commissioner Tatera was interested in the next steps for the Quimby Fund Resolution. David explained and is hoping to have the resolution to Council in November. Commissioner Wilson requested an update so the commission may possibly attend the meeting.

#### PARK AND RECREATION MANAGER'S REPORT

Parks & Recreation manger, David C. Coleman advised the commission that if he does not have an item listed from the previous suggested item listed in the agenda, he will discuss the item in his managers report. He also advised the commission that the Assistant Town Manager had already approved the community Zumba to continue using the Recreation Center. David discussed the golf course water details and upcoming programs that the department has

recently hosted.
