RECOMMENDED ACTION

That the Town Council:

- A. Accept the work completed as part of the Resurfacing 2019-03 Project No. 2019-05 for a total contract cost of \$237,084.00.
- B. Direct the Town Clerk to file the Notice of Completion for the contract work.
- C. Direct the Finance Director to release the retained funds 30 days after the Notice of Completion has been filed, provided no claims are filed against the contractor.

BACKGROUND

The project consisted of providing necessary labor, equipment and materials for the application of cold mixed asphalt on multiple street segments within the Town of Apple Valley and all other tasks as specified in the plans and technical specifications and as directed by the Town Engineer.

ANALYSIS

Engineering staff inspected the project area and deemed the work to be complete and acceptable.

FISCAL IMPACT

Funding has been appropriated in the adopted FY 2019-2020 budget, and the project was completed within budget.
