The project consisted of providing necessary labor, equipment and materials for the application of cold mixed asphalt on multiple street segments within the Town of Apple Valley and all other tasks as specified in the plans and technical specifications and as directed by the Town Engineer.

Engineering staff inspected the project area and deemed the work to be complete and acceptable.
