RECOMMENDED ACTION

That the Town Council:

- A. Find that a portion of the 30-foot-wide sewer easement (instrument number 89-216802) located at the Lewis Center for Educational Research, APN 473-183-21, has been superseded by relocation and there are no other public facilities located within the easement:
- B. Adopt Resolution No. 2020-04 "A Resolution of the Town Council of the Town of Apple Valley, California, vacating a portion of the sewer easement (instrument number 89-216802) located at the High Desert "Partnership In Academic Excellence" Foundation, APN 473-183-21, pursuant to the Streets and Highway Code Section 8333(c)";
- C. Instruct the Town Clerk to cause the Resolution vacating a portion of the sewer easement to be recorded in the office of the County Recorder of the County of San Bernardino, pursuant to Section 8333(c) of the Streets and Highways Code.

BACKGROUND

Staff received a request from the High Desert "Partnership In Academic Excellence" Foundation (Lewis Center for Educational Research) to vacate a portion of the sewer easement located on their parcel at 17500 Mana Road, APN 473-183-21. The subject easement is located along the westerly portion of the parcel as shown on the first exhibit "B", attached to this Resolution. It is determined that the sewer line was abandoned in this easement and relocated as shown in the second exhibit "B" attached to the new sewer easement.

The sewer easement may be summarily vacated under the provisions of Section 8333(c) of the Streets and Highway Code because, "the easement has been superseded by relocation and there are no other public facilities located within the easement." Because the sewer easement has been relocated over the actual sewer line, a portion of the existing easement is superseded. No posting, advertising or public hearing is necessary. Once the Council adopts the resolution vacating the easement, the Town Clerk will record the resolution of vacation. After the resolution is recorded, the vacation is complete.



RESOLUTION NO. 2020-04

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF APPLE VALLEY, CALIFORNIA, VACATING A PORTION OF THE SEWER EASEMENT AT THE HIGH DESERT "PARTNERSHIP IN ACADEMIC EXCELLENCE" FOUNDATION, APN 473-183-21, PURSUANT TO THE STREETS AND HIGHWAY CODE SECTION 8333(C)

WHEREAS, the Town Council of the Town of Apple Valley, California, intends to vacate a portion of a 30-foot wide sewer easement lying on a portion of APN 473-183-21, described in document recorded June 15, 1989 as Instrument No. 89-216802, Official Records, San Bernardino County, State of California; and

WHEREAS, the Town Council of the Town of Apple Valley now finds that it is now in the public interest that a portion of said sewer easement be vacated, and the easement has been superseded by relocation and there are no other public facilities located within the easement, it hereby meets the requirements of section 8333(c) of the Streets and highway Code;

NOW, THEREFORE, BE IT RESOLVED THAT THE TOWN COUNCIL OF THE TOWN OF APPLE VALLEY, CALIFORNIA, FINDS, DETERMINES AND ORDERS AS FOLLOWS:

<u>Section 1.</u> That pursuant to the Public Streets, Highways and Service Easements Vacation Law, Division 9, Part 3 Chapter 4, (Summary Vacation), California Streets and Highways Code beginning at section 8300, relating to the vacation of public streets, highways, and service easements, the following described easement for sewer purposes is hereby vacated:

See attached Legal Description and Exhibit "B"

Affects Assessor's Parcels: 473-183-21

<u>Section 2.</u> The Town Clerk shall record this Resolution of vacation pursuant to Streets and Highways Code section 8336.

<u>Section 3.</u> That from and after the date this Resolution is recorded, said sewer easement shall no longer constitute an easement for sewer purposes hereinabove described.

<u>Section 4.</u> If any section, subsection, sentence, clause or phrase of this resolution is for any reason held to be invalid or unconstitutional by decision of any court of competent jurisdiction, the Town shall be deemed to have adopted this resolution without such section.


