RECOMMENDED ACTION:

That the Town Council:

- A. Open Public Hearing;
- B. Close Public Hearing.
- C. Adopt Resolution No. 2020-05, confirming delinquent utility fees and costs against real property located in the Town, and directing that said assessments constitute a lien upon said properties;

SUMMARY:

Each year the Town initiates and records liens on real property for all delinquent utility fees as permitted in the Government Code. This report identifies all delinquent utility accounts and approves Resolution No. 2020-05 initiating and approving the winter lien process.

BACKGROUND:

The Government Code allows cities to collect delinquent rubbish collection and sewer fees by recording a lien against the real property and adding that amount to the property tax bill. The Town has identified the delinquent accounts as those listed in Exhibit A.

All of the billing parties and the property owners have received sufficient notification of the delinquency and have been notified of the Public Hearing to apply the delinquency to the property tax bill. For delinquent rubbish collection accounts, please see the flow chart attached (Attachment 1) which illustrates how many times the delinquent rubbish collection billing parties and property owners have been notified. The correspondence also offers an opportunity to make corrections. A sample of one of the letters is also attached (Attachment 2).

In addition to the notices and this Public Hearing, Town Finance staff allows billing parties and property owners until Thursday, February 20, 2020, to pay the delinquency before the lien is processed.

RESOLUTION NO. 2020-05

A RESOLUTION OF THE TOWN COUNCIL OF THE TOWN OF APPLE VALLEY, CALIFORNIA, CONFIRMING DELINQUENT UTILITY FEES AND COSTS AGAINST REAL PROPERTY LOCATED IN THE TOWN OF APPLE VALLEY AND DIRECTING THAT SAID ASSESSMENTS CONSTITUTE A LIEN UPON SAID PROPERTIES.

WHEREAS, pursuant to Section 38773.5 of the Government Code and Town Ordinances enacted pursuant thereto, the Town of Apple Valley has prepared a report setting forth the costs of delinquent utility fees on certain real property within the Town, and;

WHEREAS, having received and considered said report, and having noticed the affected property owners and given them an opportunity to be heard;

NOW, THEREFORE, BE IT RESOLVED, FOUND, DETERMINED AND ORDERED BY THE TOWN COUNCIL OF THE TOWN OF APPLE VALLEY, CALIFORNIA, AS FOLLOWS:

Section 1: The report setting forth the costs of delinquent utility fees and a description of each property upon which an assessment is made, copies of which is attached hereto and incorporated herein by this reference, is confirmed.

Section 2: A certified copy of the confirmed report shall be filed with the Town Clerk.

Section 3: A certified copy of the Resolution of Confirmation shall be transmitted to the Recorder of the County of San Bernardino for recording and to the Assessor and Tax Collector of the County of San Bernardino and after recordation, shall constitute special assessments against the property to which they relate, and shall constitute liens on the property in the amount of the assessment to be added to the tax bill next levied against the property.
