Lawrence McCarthy, Apple Valley, commented on the speed limit on Apple Valley Road. He spoke of the high speed of traffic in the area and believed that a change should be made for safety.

Mr. Miller explained the evaluation of speed limits according to state law and the factors that are taken to develop the limits according to the 85% percentile.
