RECOMMENDED ACTION

- A. Award a contract to Jergensen's Construction for the Highway 18 Shoulder Median Improvement Project No. 2020.02 subject to "Approval as to Form" by the Town Attorney and "Approval as to Content" by the Town Manager;
- B. Approve Budget Amendment 35.

BACKGROUND

The purpose of the project is to repair the medians and drainage channel along the State Route 18 corridor from Navajo Road to Central Road which separates the highway and the outer highway. In addition, the project will heighten pedestrian awareness and enhance the overall esthetics of the area. Improvements include adding rockscape and stamped concrete, reconstructing curb and gutter, and repairing and/or reconstructing portions of sidewalk and parkway drains. The project's design was paid for by the Village Property and Business Improvement District (PBID) and reviewed for constructability by Town staff.

On March 10, 2020, the Town received and opened bids for the subject project. The bid results are as follows:

5. Sully Miller Contracting Company	\$1,337,571.00

ANALYSIS

The bid documents for the projects were reviewed by staff for accuracy and constructability. The bid documents and the authorization to advertise were approved by Town Council on February 11, 2020. Staff reviewed the bid submissions for completeness and considers Jergensen's Construction to be a qualified, responsible and responsive bidder.

FISCAL IMPACT

Funding for this project has been appropriated in the adopted FY 2019-2020 budget. Budget Amendment 35 appropriates an additional \$8,062.78 from Drainage Impact Fees (DIF).
