RECOMMENDED ACTION

Approve the California Multiple Award Schedules (CMAS) price quote and purchase of a data storage, data backup, and disaggregated hyperconverged infrastructure (dHCl) solution in the amount of \$149,578.26.

BACKGROUND

The Town has an aging technology infrastructure that is dispersed across several platforms and components. Many of these components are approaching end-of-life, are out of warranty and/or are no longer supported to receive critial updates necessary to ensure the security of the Town's technology and avoid risk of essential systems failing.

As the Town's usage of data grows, the current storage area network (SAN), data backup and dHCl solution, is no longer capable of supporting the increasing amount of media rich content being created for the public access broadcasting channels and other mediums, along with the increased need for fast, reliable, accessible data and software used by Town Staff and Departments, including the production of quality media content.

FISCAL IMPACT

This purchase is using available funds from the PEG Channel fund balance. The purchase also utilizes the CMAS Purchasing Agreement – Contract #3-14-70-3040B, commonly referred to as a "piggyback purchasing" procedure which utilizes competitively procured products and services.
