RECOMMENDED ACTION

That the Town Council:

- A. Accept the work completed as part of the Vineyards Drainage Improvement Project for a total contract cost of \$277,100.00.
- B. Direct the Town Clerk to file the Notice of Completion for the contract work.
- C. Direct the Finance Director to release the retained funds 30 days after the Notice of Completion has been filed, provided no claims are filed against the contractor.

BACKGROUND

The Vinyards Tract (located between Nisqually Road at the South and Yucca Loma Road at the North) was designed and constructed in compliance with the Town's Development Code. Engineering staff has been monitoring the neighborhood over the years and identified an opportunity to improve drainage along Tamiani Road. The Town retained the project's engineer of record to modify the existing retention basin design to increase capacity and improve drainage by installing drywells and concrete weirs. On April 14, 2020, Council awarded a contract to TSR Construction and Inspection to construct the improvements.

ANALYSIS

Engineering staff inspected the project area and deemed the work to be complete and acceptable.


FISCAL IMPACT
