Nick Goldberg, High Tide Legal Group, reiterated the concerns expressed by Mr. Nussbaum and believed that the Town was not being fair in its proposed action to allow another tower at the Golf Course. He referred to documents he submitted to the Town regarding this item and in support of his opposition.
