La Vonda M-Pearson, Town Clerk, made calls to the following individuals for public comment:

Melissa Whetsell, Apple Valley, commented on the coronavirus pandemic and her belief that many of the concerns were unfounded. She believed meetings should be open to the public and stated that she will be speaking at school board meetings regarding distance learning.

Corina Rivera, Apple Valley, expressed concern regarding increased traffic and trash near her home. She respectfully requested the Town to do something to control this matter.

8. Discussion of Lighting Regulations

Lori Lamson, Assistant Town Manager, presented the staff report as filed with the Town Clerk. She commented on possible regulations that could be easily enforced and assist with lighting intrusion in neighborhoods.

Mayor Nassif confirmed that there are lighting regulations on new commercial development.

It was the consensus of the Town Council to direct staff to initiate a Development Code Amendment to add regulations to the Development Code that would address the issue of light nuisances and light regulations with the single-family land use.

9 Options Relating to Holding Brown Act Compliant Public Meetings During the Covid-19 Emergency

Thomas Rice, Town Attorney, presented the staff report as filed with the Town Clerk.

Council Member Cusack spoke of the disadvantage to developers when presenting their items to the Planning Commission via teleconference. He suggested that a method be designed that would allow them to be able to present their items in person during the pandemic.

Melissa Whetsell, Apple Valley, expressed annoyance regarding the County of San Bernardino still being on the watch list and the mask requirement.

Discussion ensued regarding a process moving forward that would remain in compliance with State and County mandates.

It was the consensus of the Town Council to continue to operate its meetings under Option 2 – Closed Meeting, Streamed for Public with Opportunity to Participate.

DEPARTMENTAL REPORTS AND BUSINESS

Doug Robertson, Town Manager, announced the new and improved two-member strike team in as budgeted for the Code Enforcement Division. He explained that this would assist in clean-up. He commented on the audio upgrades to the Council Chambers and thanked staff for their work in this endeavor.

Mr. Robertson also commented on Horseman Center Park and the temporarily closure due to the well. He discussed the process for reopening as a dry park on Monday, August 31 until water could be restored. He explained that staff is looking at best options available for installation of a new well; however, funding is not available at this time.
