RECOMMENDED ACTION

That the Town Council adopt Resolutions 2020-54, 2020-55, 2020-56, and 2020-57.

BACKGROUND

In 2018, California voters passed the California Drought, Water, Parks, Climate, Coastal Protection, and Outdoor Access for All Act of 2018 (Proposition 68), which directed \$254.9 million to State Parks for competitive grants to create new parks and enhance recreational opportunities for all Californians. This is the state's largest investment in grant funding history targeted for underserved communities. The bond also provides funds for aging infrastructure, amenities and improvements to parks that will help attract new and diverse visitors.

The Parks and Recreation Department and the Parks and Recreation Commission have chosen the following projects to submit to the application process:

Hilltop Park – Creating a pristine observation area that architecturally resembles the historic Hilltop House and creating multiple trails to access the property.

Standing Rock Adventure Park – a 20-acre park with multiple amenities chosen by residents.

Pahute Park – A collaboration between the Town and the AVUSD for Sports Fields and playgrounds located behind the AVUSD Offices.

James Woody Park Rehab – Adding amenities and improvements for sports and family activities.

The Parks and Recreation Commission has approved the same resolutions. As part of the application process, Town Council must approve a resolution for each application.
